Moved by Vigesaa, seconded by Ballensky approving Building Permit #2001 with \$10.00 fee submitted by Dorian Sigman for replacing cabinets and flooring in his home on Block 5, Lot 10-12.

The council members denied a request for water & wastewater services from Claryca Mandan for the property on 320 North Avenue.

Travis Frey with Interstate Engineering presented the plan for the sewer project. He addressed some issues with a couple of manholes and made a recommendation to get those updated. Surveys will be done on some of the intersections within this week. Moved by Vigesaa, seconded by Ballensky approving the Master Service Agreement to proceed with the process for the sewer project.

Chapman was advised by the council to order 4 or 5 barrels of tar to be used for the bike path and the boat ramp. Job ads for summer helpers will be published in mid-April.
