Moved by Ballensky, seconded by Kalmback approving a building permit #2023 submitted by Lloyd Bergstad to remove a trailer from his property on Blk 46, Lot 5 & 6. Within the City Ordinance, he will not be able to place a trailer back on this property. Roll call vote: All members voted aye, carried.

Moved by Ballensky, seconded by Vigesaa approving the Insured Cash Sweep account with Union State Bank. Roll call vote: All members voted aye, carried.

Moved by Ballensky, seconded by Kalmback approving the payment requested by Tand Construction, LLC for the work completed in the amount of \$97,853.22. Roll call vote: All members voted aye, carried.

Ballensky discussed with the other council members to install a hand railing at the Civic Center. He plans to get this installed soon.

Discussion was held regarding to electricity being used during the sewer project by contractor. The council agreed to double the days that the contractor is plugged into the residents' homes, and the amount will be covered by the City.
